Dr. Raphael Warnock's: The Divided Mind of Black Church
Theology, Piety & Public Witness

Historically the faith of the black church has been shaped and by two complementary yet competing sensibilities **revivalist piety and radical protests** moreover this tension plays out in the divided mind of the black church in the dialogue between black pastors and black theologians about the churches essential mission (pg. 13)

Black Church Resistance: Of the American churches the black churches offered the longest and most radical and sustained response to racism (pg. 14) . 1. The Invisible institution, 2. The formation of the liberationist faith (the black church movement. 3. Church led liberationist movement (Civil rights movement) 4. The formation of Black Theology 5. Integration: The flowering a self-critical liberationist community. Black theologians and pastors committed to new risk-taking dialogue, for challenging together structures of systemic sin and injustice in the social order and in the churches and developing together public and pastoral theology of liberation, healing, and wholeness. Facts: Black Church

Landowning asset of black people

Largest institutional site of black-led leadership

Acted as “liminal space” from slavery to ongoing fight for liberation

A spiritual resource to soothe our suffering and supplant a hopeful future

A site of production and protection of black joy, culture, music, rhetoric, and justice movements

Dr. Brianna Parker's, "I Still Believe in the Black Church

71% of black adults believe faith plays an important role in their lives (pg. 18)

Only 15% of black adults and 22% of black churchgoers believe the church to be liberating (pg. 24)

The community generally believes the black church's priority is to teach the bible, provide spiritual guidance, and address poverty issues. The church has become responsible for transforming the spirit and not the world, accepting what comes, and responding within its capacity for service.

75% of black churchgoers and 73% of the general public believed they were politically powerless. (pg. 37)

Risk-Taking Dialogue

- Has your church become responsible for transforming the spirit and not the world? Where does your church fall on the continuum of piety and radical protest?
- Dr. Brianna Parker survey indicates most people do not experience our churches in the convocation as liberating, name at least two reasons why?

Changing States lays out six decision-making arenas as target areas for organizing efforts to push, pass, and protect progressive policies and systemic change. These include the electoral, legislative, judicial, administrative, cultural, and corporate arenas. Together these define the full terrain where ideas, policies, and power are contested—and this tool is designed to help facilitate an ongoing understanding of what opportunities exist to shift power in each arena.

Missouri organizations' ability to successfully contest for power in these arenas are developed by gradually increasing sophistication in two competencies:

One, they must create a clear analysis about the power structure and key actors that pull the levers in that arena. This is built through ongoing research and a nuanced understanding of alliances, relationships, and influential players.

Second, they must develop the ability to deploy multi-layered strategies that disrupt the current power structure and create progressive alternatives.

Black Diaspora Historical Wins & Lessons

- The Haitian Revolution: 1791-1804 Haitian people who were enslaved through a series of conflicts became *the first country to be founded* by former enslaved people.
- The ANC South African Anti-Apartheid Movement (1912- 1992) first black head of state and the first elected in a [fully representative](#) democratic election in 1994.
- The Civil Rights Movement (1954-1968) Civil Rights Act of 1964 and the Voting Rights Act of 1965, Fair Housing Act 1968.
- Black Panther Movement (1966-1980), 10-Point Plan, Economic Exploitation and Abolition of Capitalism as the roots of oppression.
- Black Lives Matter Movement(2013-Present) Abolition of Prison Industrial Complex, Defund the Police, Police Brutality, Black Futures, Black Healers Network.

Black Diaspora Historical Wins & Lessons

Targets

- France and Britian
- Minority ruling class Afrikaner
- Federal Branch: President and Congress
- State Legislature
- Government Leaders/Police

Tactics

- Rebellion demanding representation, Abolition of Slavery, Collaboration with free people of color, Religion: Vodou, Raids
- Economic Boycotts
- Non-Violent Demonstrations
- Armed action on state officials, Survival Programs/Mutual Aid Organizing Local and International Chapters decentralized leadership, imagery and symbols
- Mass Demonstrations, Organizing Local and Regional Chapters decentralized leadership, Faith Leadership
